

Terra Australis National and Commonwealth of Australia Declaration of Political Status.

For Naturalised Australian Citizens Adopting State National or State Citizen Status for the First Time

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that this Declaration of Political Status is to record **John Adam Doe** return to the Land and Soil Jurisdiction of Terra Australis and The Commonwealth of Australia.

I declare that I am the owner and operator of my vessels on Earth from the moment my zygote first formed, together with all DNA and all substance matter in any way associated with me and my incarnation, and I further declare that I accept my divine origin and all honour, right, title, and material interests I am owed;

I hereby declare my political status as a Terra Australis and Commonwealth of Australia State National, freely choosing to live within the physical borders of **Queensland** State;

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia that I reject, renounce, and remove any contrary Powers of Attorney granted by me or issued under my name prior to this day;

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I reject, renounce, and remove all and any allegiance to any queen, king, prince, princess, any foreign State, foreign government, flag or thing that is not subject to Terra Australis and the Constitutions owed to The Commonwealth of Australia and its member States;

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I have never knowingly, willingly, and voluntarily pledged myself to any incorporated entity at all, including but not limited to any incorporated church, synagogue, mosque or temple;

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I wish to be recognised as one of the people of Terra Australis, The Commonwealth of Australia and **Queensland** State, to enter into all the rights, guarantees, and blessings of freedom, and I accept my responsibility to keep the peace and do no harm;

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I wish to be recognised as one of the people of the commons of Terra Australis, and the people of the Land and Soil Jurisdiction; And whereas the term 'Commonwealth', is biblically defined and references the wealth of the people of the Land and Soil Jurisdiction, or the wealth of the land of the people, excluding the Crown Corporation's definitions of 'COMMONWEALTH';

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I wish to be recognised as part of the body called 'We the People' and by this Declaration of Political Status, form a free, sovereign and independent island State called Terra Australis, Land and Soil of our forefathers, commonly known as 'The Commonwealth of Australia';

I declare under penalty of perjury under the Public Law of the Commonwealth of Australia, that I wish to retire from the Territorial Government operating a commercial corporation, calling itself the COMMONWEALTH OF AUSTRALIA and operating as AUSTRALIA, INC., and QUEENSLAND (QLD) INC., NEW SOUTH WALES (NSW) INC., VICTORIA (VIC) INC., SOUTH AUSTRALIA (SA) INC., WESTERN AUSTRALIA (WA) INC., NORTHERN TERRITORY (NT) INC., AUSTRALIAN CAPITAL TERRITORY (ACT) INC., and TASMANIA (TAS) INC., a quasi-military Protectorate, and a subsidiary of the British Crown Corp acting as a subcontractor for Westminster;

I declare, publish, and affirm under penalty of perjury under the Public Law of the Commonwealth of Australia that my house is established in Terra Australis, **Oneshire** and my home is established in **Queensland** State and no other presumption or impersonation of my house or my home as real estate is allowed and no entitlement to my private property is granted;

I declare under the aforementioned penalties that I have been legally Naturalised as an Australian Citizen and I take this further step to adopt Terra Australis and **Queensland** State as the basis of my nationality and political status freely and without coercion. I am a Lawful Inheritor, Landlord, Keeper, and Guardian of the Rightful and Lawful Government of this country, acting with Full Right, Authority, Responsibility and Honour, now and always while my tenure on Earth shall last — and I present this Declaration of Political Status;

Notice to Principals is Notice to Agents; Notice to Agents is Notice to Principals.

This Declaration is valid, true, correct, and complete in all jurisdictions of law: air, land, and sea.
